- Texas A&M AgriLife Extension Service (AgriLife Extension) Water Well Screening Events
 - o John Smith (AgriLife Extension) reported there were no events. He also reported that seven events are planned for March, April and May.
 - TGPC Exhibit Booth:
 - There was one event booth during the last quarter. The Texas Groundwater Association's Annual convention was held in San Marcos, Texas on January 26 and 27, 2023, with about 30 attendees stopping by the booth.

TWON Training Activities

Joel Pigg (AgriLife Extension) reviewed the TWON training schedule. During the previous quarter, TWON staff held two one-day events and one one-hour event. Staff collected 193 samples. There have been over 2,028 samples or attendees at TWON events since May 2021.

TGPC Website Activity Statistics

Peggy Hunka (TCEQ) reviewed the Google Analytics activity report on the TGPC web page, which showed that in the previous quarter there was a 4% decrease in the number of users and a 5% decrease in the average number of pages viewed per session. Organic searches showed that 3,827 users arrived using a web search, with Google being used most often.
