Peggy Hunka (TCEQ), Co-Chair of the TGPC POE Subcommittee, called the meeting to order at 1:32 p.m. Attendees were introduced. The minutes were provided to the members by email for review prior to the meeting.

STATUS REPORTS

Recent and Upcoming Outreach Events

The current Outreach Events Status Report was reviewed, and is available on the <u>POE</u> <u>Subcommittee webpage</u>¹ under the "Additional Resources" heading:

 - o John Smith (AgriLife Extension) reported there were two events in August with eight more events planned for September and October.
- · TGPC Exhibit Booth:
 - TCEQ's 2023 Public Drinking Water Conference was held August 8 9, 2023 in Austin and on August 29 – 31, 2023 the Texas Alliance of Groundwater Districts held their annual Groundwater Summit in San Antonio, Texas. We estimate that 233 people came by and viewed the TGPC booth at these two conferences.

TWON Training Activities

John Smith (AgriLife Extension) reviewed the TWON training schedule. During the previous quarter, TWON staff held two one-day events and two one-hour event. Staff collected 159 samples. There have been over 2,593 samples or attendees at TWON events since May 2021.

TGPC Website Activity Statistics

Peggy Hunka (TCEQ) reviewed the Google Analytics activity report on the TGPC web page, which showed that in the previous quarter there was a 4% decrease in the number of users and a 5% decrease in the average number of pages viewed per session.
